Matsayi

Hukumar tabbatar da yin aiki da Ka'idoji da sharrudan aiki na Kulawa da Jin Dadin Jama'a da kuma Hukumar Bincike da bin Diddigin aiyukan Kulawa da Jin Dadin Jama'ar zasu rika yin la'akari da wadannan ka'idoji da sharruda wajen tabbatar da cimma burin da aka tanada.

A matsayinka na mai cin moriyar aikace-aikacen ko kuma daya daga cikin sauran jama'a, ka'aidojin zasu taimaka maka wajen fahimtar halaiyar data kamata wani ma'aikacin kulawa da jin dadin jama'a ya nuna maka da kuma yadda ya kamata hukumomi ko wadanda suka dauke shi aikin su tallafawa ma'aikata wajen yin aiyukansu sosai.

Ka'idojin Aiki ga Ma'aikatan Kulawa da Jin Dadin Jama'a

Ma'aikatan kulawa da jin dadin jama'ar suna da alhakin tabbatar da cewa halaiyarsu bata kai ga gaza cimma wadannan ka'idoji ko sharrudan da aka zaiyana ba, da kuma kaucewa dauka ko kuma gaza daukar duk wani mataki wanda zai yi illa ga lafiyar masu cin moriyar aikace-aikacen nasu.

Matsayi

Hukumar kula da Aiyukan Kulawa da Jin Dadin Jama'a tana bukatar ma'aikatan kulawa da jin dadin jama'ar su cimma wadannan ka'idojin kuma tana iya daukar mataki idan ma'aikatan da sukayi rijista suka gaza yin hakan.

- Kiyaye hakki ko yancin masu cin moriyar aikace-aikacen tareda tabbatar da cewa halaiyarsu bata yi illa a garesu ko kuma ga wasu ba;
- Tabbatar da amincin jama'a bisa aiyukan kulawa da jin dadin jama'ar; da kuma

- Daukar nauyi ko alhakin aiki tareda faiyace ingancin aikace-aikacen nasu da kuma cigaba da kyautata ilmi da kwarewarsu ta aiki.

- 1.4 Kiyaye martaba da mutuncin masu cin moriyar aikace-aikacen kulawar;
- 1.5 Bunkasa cin moriyar aiyukan kulawar daidai-wa-daida tsakanin jama'a; da kuma
- 1.6 Yin la'akari tareda mutunta bambancin al'adu da akidoji.

- 2.3 Mutunta bayanai na sirri tareda yin bayani bisa munufofin hukuma a gameda bayanan na sirri ga masu cin moriyar aiyukan kulawar da kuma masu yinsu;
- 2.4 Kasancewa abun-dogaro;
- 2.5 Cika-aiki, da cimma yarjejeniyoyi da tsare-tsare da kuma yin bayani ga masu cin moriyar aiyukan kulawar tareda masu yinsu, idan hakan ta faskara, bisa dalilan da suka jawo gazawar.
- 2.6 Baiyana batutuwan daka iya kaiwa ga nuna son-kai tareda tabbatar da cewa basu shafi shawarwari ko kuma aiyukanka ba; da kuma
- 2.7 Yin aiki da manufofi hade da matakan da suka shafi karbar kyaututtuka da kudi daga masu cin moriyar aiyukan kulawa da jin dadin jama'a da kuma masu yinsu.

- 3.3 Bin ka'idoji ko sharruda da kuma daukar matakan da aka tsara da nufin kare ka tareda sauran jama'a daga yamutsi da kuma cin-zarafi a wajen aiki;
- 3.4 Sanarda hukuma ko cibiyar data dauke ka aiki ko kuma wata hukumar data dace bisa wasu matsalolin da suka jibanci kayan aiki ko gudanar da aikin wadanda ka iya kawo cikas ga kulawa da jin dadin jama'a;

- 3.7 Taimakawa masu cin moriyar aiyukan da kuma masu yinsu wajen gabatar da koke-kokensu da daukar koke-koken nasu da mahimmanci ainun, da kuma daukar mata kai a kansu ko gabatar dasu ga wanda ya dace; da kuma
- 3.8 Fahimtar ikonka na aiki tareda yin amfani dashi ta hanyar data dace wajen yin hulda da masu cin moriyar aikin da kuma masu yinsa.

4 A matsayinka na ma'aikacin kulawa da jin dadin jama'a, dole ne ka kiyaye hakkin masu cin moriyar aikin, tareda tabbatar da cewa halaiyarsu bata yi illa a garesu ko kuma ga wasu ba.

- 4.4 Tabbarar da cewa abokan aikinka tare da hukumomin da suka dace suna da masaniya bisa sakamako da kuma illolin dake tattare da bin diddigin abubuwan daka iya kasancewa suna da hadari.

- 5.4 Kulla wata dangantaka ko yin huldar da bata dace ba tsakaninka da masu cin moriyar aiyukan;
- 5.5 Nuna bambamci ba bisa doka ko hujja ba ga masu cin moriyar aiyukan kula da jin dadin jama'ar ko kuma abokan aikinka;

- 5.6 Amincewa da duk wani nuna bambamci ba bisa doka ko hujja ba daga masu cin moriyar aiyukan kula da jin dadin jama'ar ko kuma abokan aikinka;
- 5.7 Saka kanka ko wasu cikin hadari haka-siddan; ko kuma
- 5.8 Nuna wata halaiya a wajen aiki, ko kuma bama a wajen aikin ba, wadda zata sa a rika shakku bisa cancantarka ta yin aikin kulawa da jin dadin jama'a.

6 A matsayinka na ma'aikacin kulawa da jin dadin jama'a, dole ne ka dauki nauyi ko alhakin aiki tareda faiyace ingancin aikace-aikacen naka da kuma cigaba da kyautata ilmi da kwarewarka ta aiki.

- 6.4 Neman taimako daga hukuma ko cibiyar data dauke ka aiki ko kuma wata hukumar data dace idan kana jin cewa ba zaka iya gudanar da duk wani aikin naka sosai ba, ko kuma idan kana da shakka bisa yadda zaka tunkari wani fanni na aikin;

- 6.7 Fatimta tareda mutunta matsayi da kwarewar ma'aikatan wasu hukumomin, da bayarda hadin-kai domin yin aiki tareda su; da kuma
- 6.8 Yin duk wani horon daya dace, da inganta ilmi da kwarewarka ta aiki, da kuma bayarda gudun-mowa ga shirin ilmintarwa da horo ga wasu.
